#### **INTRODUCTION**

### TRAVELLING AND FEES CONCERNED

We service anywhere in South Africa but mainly focus on our 500 plus customers that we service in Kwa-Zulu Natal. Although WP is based in Empangeni he services anywhere from Pongola, Kosi Bay right up to Sani Pass and furtherer if required. A booking is required at least a week in advance or the next available booking date for polygraph testing.

We charge per polygraph test or pre-employment test carried out. Our travelling fees are calculated according to the mileage travelled per kilometer. A cancellation fee per test booked is also applicable when a confirmed date is cancelled in less than 48 hours. These prices are subject to change prior to any notice.

#### **CONTRACTS AND PACKAGES**

We offer competitive monthly retainers for large companies that require polygraph testing on a regular basis such as Security Companies that require a polygraph test to be done prior to employment. We charge a monthly fee irrespective of the amount of polygraph tests undergone for the month. This agreement can be arranged by signing a monthly retainer contract which services anywhere from three months until however long you require the contract.
